This instrument will not be used in any organization which is not a part of FCPS curriculum without the written consent of the school principal and music instructor. 4. The instrument will not be used in employment which results in personal remuneration. 5. The instrument and accessories will be surrendered immediately upon request of the music instructor or other school official. 6. The undersigned will abide by all the rules and regulations of the school instrumental music program. 7. The undersigned will provide such equipment as designated by the instrumental music instructor. 8. The student will participate in school organizations and music functions promoted by FCPS, as requested by the instrumental music instructor and the principal. 9. The undersigned will pay the stipulated fee which does not include accessories such as: reeds, valve oil, rosin, shoulder rest, rock stops, etc. 10. The undersigned shall be responsible for the instrument and accessories and if the instrument or accessories are damaged due to other than fair and normal use, will pay the amount of the damage, or will replace the instrument and accessories with an instrument or accessories according to the FCPS "Standards for Equipping Schools".
